## **Compton Bassett Parish Council Website Accessibility Statement**

### 1 Introduction

The Parish Council is required to have a website accessible for all users and a Website Accessibility Statement by the Public Sector Bodies (Website and Mobile Applications) (No 2) Accessibility Regulations 2018, which came into force in September 2018. This statement has been compiled in collaboration with the Council's IT advisor and a review of national guidelines and a sample of statements from similar bodies.

## 2 Website Accessibility Statement

This statement refers to the Compton Bassett Parish Council section of the Compton Bassett village website only. The village website is owned by Manor Cottage Studios, who upload and manage content supplied by Compton Bassett Parish Council for their section of the website. Accessibility means that the parish council element of the website is designed to be used by as many people as possible. For example, users are able to:

- zoom in by up to 300% for optimal text reading
- · navigate most of the website using just a keyboard
- listen to most of the website using a screen reader (including the most recent versions of JAWS, NVDA and VoiceOver).

Our intention is always to use clear English for clarity of understanding. AbilityNet has advice on making your device easier to use if you have a disability.
