  - b. **War Memorial** The Clerk has sent a letter of thanks to Laurie Waite to be passed to the anonymous donor for their generous donation of £275 to pay for repair works to the steps
  - c. **Speed checks and indicator** Sonya Stockhill arranged a speed check in the village on December 11<sup>th</sup>. No tickets were issued. Another speed check will be carried out in the near future by the police. Parish Councillors will arrange further speed checks in the spring.
    - The Clerk is waiting to hear back from Wiltshire Council regarding the possibility of a speed indicator device for the village.
    - County Cllr Crisp advised Calne Town Council are looking at the possibility of taking on the speed indicators
  - d. **Parish Council Laptop** Cllr Coward is going to help the Clerk and Cllr Waite look into the various laptops and office packages that are available and advise on the most suitable buy.
  - e. **Precept** The Clerk has submitted the precept request for year 2016/17. As all previously agreed the precept will stay the same as last year . Precept £3474.42, top up grant £22.92 Total £3497.34 from Wiltshire Council
- **6 Neighbourhood Plan** Anna McBride of Wiltshire Council has requested a revised map Showing the extent of the allocated area at Briar Leaze for the proposed Green Square Group development area.

- **7 Broadband** Cllr Alberry advised talks and meetings continue with BT over the problems with BT broadband in the village and the possibility of super fast broadband for the village.
- **8 Hills** Hills' Lower Compton have now put in CLUED and Section 73 planning applications to Wiltshire Council. A letter has been sent to Jason Day at Wiltshire Council objecting to the applications.
- **9 Green Square Update** The Green Square Group planning application for proposed 13 new dwellings and associated works following demolition of 6 existing dwellings and garages at Briar Leaze has now been submitted to Wiltshire Council. Planning application ref 15/12294/FUL All comments and responses to be received by Wiltshire Council by 11<sup>th</sup> February 2016. All councillors agreed the response of the Parish Council "as support subject to conditions "as follows:

"The developers appear to have made an attempt to comply with the Compton Bassett Neighbourhood Plan. However Compton Bassett Parish Council would ask Wiltshire Council to look at the following:

The width of the access road into Briar Leaze, the size and number of car parking spaces and the green space to be provided. To be in keeping with the rest of the village and comply with the requirements of the Neighbourhood Plan there would be no street lighting. It is known bats use the roofs and crevices of the houses for roosting so timing of the demolition is crucial. Nesting birds will also need to be considered."
