The phone box is now in its new position and will soon be fitted with the defibrillator

It has taken longer than expected due to lockdowns etc. Thank you to the Councillors who's hard work got it finally ready.

The next project is to clean and paint the bus shelter.

The Freeth farm planning application for conditions for sand extraction and a conveyor to move the sand is still undecided. This will be discussed at item 19 on tonight's agenda.

We had a few planning applications in the last year mainly tree removal etc. and one application which was refused.
