**5/21 Actions & Matters Arising:** Phonebox – LW has circulated photos, the phonebox has been sandblasted and painted. Now waiting for covid restrictions to be lifted so it can be installed.

White lining by Church JM This has now been accepted on the CATG priority list, it will be costed at the next CATG meeting, estimated cost is £2,500, the parish council will have to pay 30% of the cost. PS proposed the parish council pay 30% of up to £2,500. This was unanimously agreed. **Action:** JM to advise at next CATG meeting

Village archives LW has started to organise a catalogue and will update us again in the summer.

Overgrown bush by bus shelter PS will be carried out when bus shelter is painted, on hold due to covid restrictions.

Parish steward visits PB The steward visited the village on 6<sup>th</sup> January, he worked on the drains at Freeth Corner and in the village. More work is required on the village drains. He also carried out work to the pavements. Please contact PB with task requests for the steward.

Woodland Trust Trees JM these would be available for November, awaiting site location reference from Buttle Farm

Tree guards for hornbeam trees at war memorial **Action:** LW will install Waste bin at play park Briarleaze JM Street Scene were very helpful, there are 2 bins available one by the playpark and one by the bus shelter. If properly wrapped dog waste can be put in these bins.

Wildlife in village JB has been in contact with Wiltshire Wildlife Trust to look for ways to promote wildlife in the village.

Light pollution JM has written an article for the next newsletter. JM has also circulated an email to councillors before the meeting which they unanimously approved for sending to GreenSquare. **Action:** DZ to send email to GreenSquare Gigaclear Up and running in village

On line banking DZ after putting in a complaint to Lloyds Bank we now finally have 4 councillors sent up for on line banking, LW, JM, JB and PS

Damaged marker by war memorial DZ has had no response from either the contractor who damaged the marker or the agents Cooper & Tanner. PS proposed the marker should be replaced this was unanimously agreed. After discussion, PS proposed DZ phone Cooper & Tanner, this was unanimously agreed. **Action:** LW to source new marker, DZ to phone Cooper & Tanner

The parish council can signpost how to get help but are not in a position to help. JM has previously circulated a neighbours dispute policy this was unanimously agreed and will be put on the website. **Action:** DZ to send policy to Adrian Elmer for website

- **10/21 Website** LW The new email policy is ready to be distributed, all councillors and the clerk will be issued a gov.uk email address for use for parish council busines. It was unanimously agreed the new emails should be set up after the parish council elections.
- **11/21 Members Handbook** JM and DZ are updating the handbook so all new councillors can receive a new and up to date handbook. JM proposed the councillors names should be on a flyer in the book and not printed in it. This was unanimously agreed.
- **12/21 Communications** JB and LW will produce a printed newsletter for March/April
- **13/21 NHP Review** In line with the NHP the eco side of traffic management is being looked at.
- **14/21Councillors Observations** PS The parish magazine has always been distributed in the village with no charge but a donation request of £7 per year per household. Due to the financial situation free copies will be discontinued. There will be no copy in February. The next print run which is hoped to be in May will be only by subscription. Anyone who would like to subscribe to the magazine please contact Pete Szczesiak or Jenny Brookes

PS There were no entries for the childrens' competition run by Greensquare to design a traffic slow down sign, the village hall committee are happy for a sign to go on their land.

The houses for sale sign is also still up.

DZ to chase the removal of the houses for sale sign and enquire if GreenSquare will provide a slow down sign as the competition had been unsuccessful.
