VHC meeting LW, the new chair is organising installation of an AV system for showing of films. A licence to serve alcohol has been applied for.

The VHC are going to purchase a Christmas tree again this year and have asked the parish council for a donation. PS proposed a payment of up to ± 200 , or half the cost of the tree, whichever is lower. EB seconded this. It was unanimously agreed to give the donation this year. However, some parish councillors feel that paying ± 400 annually for a Christmas tree is rather excessive.

69/23 Website Annual Review In light of the internal auditors comments, the parish council is obliged to look at alternative providers.

70/23 Traffic Consultation SID monthly report and placement, Speed limit review, Auto speed watch device, Village gates.

The 30 and 40mph zones, Hilmarton side of the village will be extended, hopefully by end of March 2024. The parish council will have to pay a contribution of approx. £1800 to Wiltshire Council towards the signage etc

Details of an auto speed device have been circulated to the parish councillors and discussed. LW proposed the purchase of one, at a cost of \pounds 620 plus vat, with a future annual cost of \pounds 150. This will give the village 2 SID to use at different locations in the village. CR seconded and it was unanimously agreed. Action: LW to purchase auto speed device

Future purchase of village gates will be discussed at a later date.

72/23 Tree Sparrow Nesting Boxes CR, Bremhill Vales Farmers Group is a cluster group of landowners, looking to improve biodiversity, priority habitats and support priority wildlife species. Tree sparrows have declined significantly in recent years but efforts across the Marlborough Downs providing nesting boxes have been very successful. A donation of £200 is requested to provide up to 20 nesting boxes within Compton Bassett Parish. The boxes will be provided by Wiltshire Wood Recycling, a local initiative.

CR proposed a donation of ± 200 is made, EB seconded it and it was unanimously agreed.
